Patient ServicesPlanned Parenthood Los Angeles is one of the five largest affiliates in the country We have 18 health centers throughout Los Angeles and see more than 200,000 patient visits every year More than 95% of our patients have incomes at or below 200% of the federal poverty limit, and our health centers are located in regions with higher than average health disparities Planned Parenthood serves women, men and teens but the vast majority of our patients, 93%, are over the age of 18 Our customer care center answers more than 30,000 calls each month providing education and information to patients and community members, and schedules 10,000 appointments each month More than 90% of our health services are prevention focused including life-saving cancer screenings and education, early stage cervical cancer treatment, pregnancy testing and counseling, and contraception In 2010, we transitioned all of our health centers to electronic medical records, enabling us to streamline patient care and communication, doing an even better job of providing quality care to the patients who depend on us
