QUESTION 1 Part VII-B - SELF-DEALING

Questions 1(a)(1)&(3) - Leasing of property from disqualified person

These questions were answered "Yes" because of the following facts:

The Foundation rented space in Suite 960, 10960 Wilshire Blvd., and obtained secretarial services, telephone, office supplies, etc., from the firm of Olincy & Karpel for the period from July 1, 2010 to June 30, 2011. Dan Olincy, the Managing Trustee of the Foundation, is a partner in said firm. In the current fiscal year, the Foundation paid Olincy & Karpel the sum of \$37,200 for such items.

The above is not considered an act of self-dealing because it comes within the following exceptions:

This arrangement was established on April 1, 1968, and has been in effect continuously since that time.

The charge for rental is based on the amount of square footage used by the Foundation in the suite and the rate is exactly the same as that paid the lessor by Olincy & Karpel; and the office services are based on the reasonable value of same.

This specific arrangement was approved by the IRS when the Foundation was examined for the fiscal years ending June 30, 1979 through 1982.

Question 1(a)(4) - Payment of Compensation

This question was answered "Yes" because of the following facts:

A. Payments to Olincy & Karpel

Since July 28, 1982, Dan Olincy has been Foundation Manager and services were performed by Dan Olincy and members of

his firm at their usual billing rates. Dan Olincy provided the services as set forth in Paragraph B, below. The Foundation paid Olincy & Karpel the sum of \$6,226 for these services during the year ended June 30, 2010.

The above cannot be considered an act of self-dealing because it comes within the following exception:

Olincy & Karpel's compensation is reasonable, based on the time, skill and responsibilities involved in performing such duties. It is based on an analysis of the actual time required by Dan Olincy and members of his staff to perform these duties.

B. Services provided by Olincy & Karpel

Olincy & Karpel's services were necessary to carry out the Foundation's business and exempt purposes. The Foundation has no employees. Dan Olincy has complete responsibility of supervising the Foundation's investment portfolio of approximately \$503,000; he handled all grant requests to the Foundation and was involved in all grant approvals; he had supervision over the bookkeeping, financial statements, and all reports of the Foundation.
