INSTRUCTION. THE UNIVERSITY HAS 228 FACULTY MEMBERS, 63 FULL-TIME AND 165 PART-TIME. THE COLLEGE OF SCIENCE AND HEALTH (COSH) HAS 15 FULL-TIME FACULTY AND 19 PART-TIME FACULTY. COSH STUDENT ENROLLMENT FOR 2011 STOOD AT 230. THE COLLEGE OF MEDICINE (COM) HAS 35 FULL-TIME ACTIVE FACULTY AND 142 PART-TIME AND CLINICAL FACULTY MEMBERS. HALF OF THE COM FACULTY MEMBERS HAVE DUAL APPOINTMENTS WITH UCLA. CURRENT COM STUDENT ENROLLMENT CONSISTS OF 111 GRADUATE STUDENTS, AND 5 MASTERS OF SCIENCE STUDENTS. THE SCHOOL OF NURSING (SON) HAS 13 FULL-TIME FACULTY AND 4 PART-TIME FACULTY. THE SON STUDENT ENROLLMENT IS 157 MASTERS OF SCIENCE STUDENTS.

DIABETES, HYPERTENSION, CANCER, REPRODUCTIVE HEALTH, CHRONIC KIDNEY DISEASE, NEURO-PSYCHIATRIC DISORDERS AND HIV/AIDS ARE JUST A FEW OF THE AREAS WHERE CHARLES R. CHARLES R. DREW UNIVERSITY OF MEDICINE AND SCIENCE IS ENGAGED AS A TRUE RESEARCH PARTNER LOCALLY WITH NATIONALLY RECOGNIZED RESEARCH INTENSIVE INSTITUTIONS, SUCH AS THE UNIVERSITY OF CALIFORNIA - LOS ANGELES AND THE RAND CORPORATION.
