ADDITIONALLY, NUTRITION EDUCATION IS OFFERED THROUGH COOKING AND INFORMATION SESSIONS THAT COVER HEALTHY EATING AND FOOD PREPARATION, INCLUDING FOOD SAFETY. SUCH SESSIONS FOCUS ON THE FRESH PRODUCE BEING DISTRIBUTED AND HEALTHY PREPARATION METHODS.
