It includes meaning-based tutoring (in addition to spelling), a freemium model that combines free options with membership based services, and our new Open Dictionary of English (ODE). ODE is built on our proprietary data and that of our partners, and will allow users to rate and update the information in a wiki-like format. Designed as an online, usage-focused learners' dictionary, it is bound to become a data-rich online dictionary resource. It places special focus on providing learners with hands-on multi-media, usage-based examples of how the word is used, and lots of media communicating the "flavors" of words in this global language.
