Biological & Life Sciences Research: The BioBricks Foundation, Inc. (the "BBF") was established to foster and advance innovation, research, standardization, and education in synthetic biology through the open design, construction, distribution, understanding, and use of BioBrick parts, namely standardized genetic materials and associated functional information, in ways that benefit science, healthcare, and society worldwide. The BBF developed a BioBricks Public Agreement in both a Contributor and User form to encourage the contribution and use of standardized biological parts. In addition to educational activities, the BBF also was a lead organization in the launch of the BIOFAB, a consortium of research institutions which have a synthetic biology lab at the Joint Bioenergy Institute in Emeryville, CA. The BBF helped secure additional institutional partners to sponsor and participate in the BIOFAB's activities. The BBF also administers OpenWetWare, an online community of synthetic biology researchers and labs which fosters greater communication and sharing of information and resources, and educational opportunity, via the Internet. The conference brought together over 700 biological engineers from around the world who are utilizing DNA to build biological systems and bringing engineering principles to bear on biological problems. In addition to presentations of cutting-edge biotechnologies, the meetings have included discussions to place the research within its current and future social context, including issues of biosafety, biosecurity, bioethics, and intellectual property.
