Tri(y) Fitness 4 Kids is a before-school program held at Katherine Albiani Middle School. The Executive Director worked with 2-3 Sacramento State University interns as well as 2-3 volunteers throughout the school year to help lead activities with the kids. The students participated in a variety of activities including yoga, sports, bootcamp and running. They were educated on proper nutrition and incorporating recreational activities in their daily routine. Approximately 30-40 kids were involved in this program which lasted the entire school year. We measure their progress based on fitness tests and body measurements. In addition, we also base their success on attendance, enthusiasm and willingness to become more active on a daily basis.

4b (Code:) (Expenses \$ 8,500.00 including grants of \$) (Revenue \$)

Fitness Field Trips were provided for students to allow them to enjoy recreational, physical activity outside a gym class setting. Some trips include indoor rock climbing, horse back riding, hiking, swimming and cooking classes. These trips were planned every couple months and approximately 20-30 students attended.

4c (Code:) (Expenses \$ 5,600.00 including grants of \$) (Revenue \$)

Parent Transformation Program is a program designed to educate parents on the importance of good nutrition and weekly exercise. FWB held a Sunday bootcamp, in which the parents and the student attended. We utilized motivational tools such as daily food tracking logs and a reward for having the biggest transformation. This program lasted 3 months and approximately 25 parents participated.
