ARE OUT AND SUCCESSFUL BOTH PROFESSIONALLY AND PERSONALLY. THE WIDER COMMUNITY CAN SEE THAT GAY, LESBIAN,
BISEXUAL AND TRANSGENDER PEOPLE AREN'T A SCARY BUNCH. THEY ARE OUR NEIGHBORS, OUR COWORKERS, OUR FRIENDS,
AND OUR FAMILY MEMBERS. WE REACHED OVER 800 PEOPLE WITH THE EVENT FOR A COST OF \$4363.

LINE 29 SPENCER PRIDE EDUCATES THE COMMUNITY DURING GLBT HISTORY MONTH IN OCTOBER THROUGH A FREE FILM EVENT
AND EXHIBITING EDUCATIONAL DISPLAYS AT MORE THAN 15 AREA PUBLIC LIBRARIES AND SCHOOLS. THE LIBRARIES AND SCHOOLS
ARE IN PLACES THAT DON'T OFTEN SEE LGBT INFORMATION ON DISPLAY. THE FILM EVENT SERVES TO EDUCATE THE LOCAL
COMMUNITY ABOUT LGBT ISSUES. THROUGH THESE EFFORTS WE REACHED AND EDUCATED OVER 900 PEOPLE AT A COST OF \$50.
