RESEARCH - WE PRINTED MATERIALS THIS YEAR REVIEWING SCIENTIFIC EVIDENCE OF THE VACUUM EFFECT. "THE VACUUM EFFECT: WHY CATCH AND KILL DOESN'T WORK" SUCCESSFULLY OUTLINES THE FUTILE APPROACH OF CATCH AND KILL. WE ALSO PUBLISHED THE FINDINGS FROM OUR TEN-YEAR SPAY/NEUTER CLINIC, WHICH MIRROR THAT OF PEER-REVIEWED STUDIES: 98% OF CATS BROUGHT TO ALLEY CAT ALLIES CLINIC OVER THE TEN-YEAR PERIOD WERE RETURNED TO THEIR OUTDOOR HOME. ANOTHER 1% HAD POSITIVE OUTCOMES. THE DATA CONFIRMS THAT FERAL CATS LIVE HEALTHY LIVES OUTDOORS: LESS THAN HALF OF A PERCENT WERE EUTHANIZED DUE TO MEDICAL ISSUES.

EXPOSING MISINFORMATION - THIS YEAR WE STEPPED UP OUR EFFORTS TO CORRECT MISINFORMATION AND MYTHS ABOUT CATS' IMAGINED IMPACT ON WILDLIFE. WHEN FERAL CATS WERE TARGETED AND THREATENED, ALLEY CAT ALLIES MADE SURE THE FACTS WERE BROUGHT TO LIGHT.

THE MISINFORMATION ABOUT CATS, INCLUDING THE PREVIOUSLY MENTIONED PAPER WRITTEN BY STUDENTS AT THE UNIVERSITY OF NEBRASKA, USED FLAWED RESEARCH AND SCARE TACTICS TO SUPPORT THEIR CLAIMS AGAINST CATS; DISREGARDED THE SCIENTIFIC EVIDENCE PROVING THE EFFECTIVENESS OF TRAP- NEUTER-RETURN; AND IGNORED THE REAL THREAT TO ANIMALS-HUMANS AND OUR IMPACT. ALLEY CAT ALLIES' RESEARCH AND EDUCATIONAL OUTREACH WORKED TO CORRECT THE MISCONCEPTIONS AND EFFECTIVELY COUNTER THE OPPOSITION WITH LETTERS TO THE EDITOR, MEDIA OUTREACH, AND EDUCATIONAL RESOURCES.
