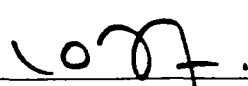

AMENDED AND RESTATED
ARTICLES OF INCORPORATION
OF
TRINITY CHRISTIAN ACADEMY EXCELLENCE FUND

A Texas Non-Profit Corporation

Charter No. 727699

ARTICLE ONE

Pursuant to the provisions of Art. 1396-4.06 of the Texas Non-Profit Corporation Act and the Texas Miscellaneous Corporation Laws Act, Trinity Christian Academy Excellence Fund (the "Corporation") hereby adopts restated articles of incorporation which accurately copy the articles of incorporation and all amendments thereto that are in effect to date and as further amended by such restated articles of incorporation as hereinafter set forth and which contain no other change in any provision thereof.

ARTICLE TWO

The articles of incorporation of the Corporation are amended by the restated articles of incorporation as follows:

- (a) By amending Article I to change the name of the Corporation.*
- (b) By changing all references to the board of trustees to the board of directors.*
- (c) By amending Article VII to provide the directors of the Corporation with the ability to hold meetings by written consent in accordance with the provisions of Article 1396-9.10 of the Texas Non-Profit Corporation Act.*
- (d) By revising the language in Article VII providing for director and officer indemnification pursuant to the provisions of the Texas Non-Profit Corporation Act.*
- (e) By amending Article VIII to provide that no amendment to the articles of incorporation of the Corporation or the bylaws of the Corporation will be effective without the approval of Trinity Christian Academy.*
- (f) By replacing the current Article XIII with language providing for a limitation of the liability of directors to the Corporation in certain circumstances, pursuant to the provisions of the Texas Miscellaneous Corporation Laws Act.*

(g) *By revising references to the Internal Revenue Code of 1954 to the Internal Revenue Code of 1986.*

ARTICLE THREE

Each such amendment made by the restated articles of incorporation has been effected in conformity with the provisions of the Texas Non-Profit Corporation Act and such restated articles of incorporation and each such amendment made by the restated articles of incorporation were duly adopted by a majority of the trustees of the Corporation in office at a meeting of the board of trustees on April 24, 1997, there being no members of the Corporation.

ARTICLE FOUR

The articles of incorporation and all amendments and supplements thereto are hereby superseded by the following restated articles of incorporation which accurately copy the entire text thereof and as amended as above set forth:

ARTICLE I

The name of the Corporation is Trinity Christian Academy Foundation.

ARTICLE II

The Corporation is a non-profit corporation and shall have all of the powers, duties, authorizations and responsibilities as provided in the Texas Non-Profit Corporation Act; provided, however, the Corporation shall neither have nor exercise any power, nor shall it engage directly or indirectly in any activity, that would invalidate its status as a corporation that is exempt from federal income taxation as an organization described in section 501(c)(3) of the Internal Revenue Code of 1986, as amended (or corresponding provisions of any subsequent federal tax law), or as a corporation contributions to which are deductible under section 170(a)(1) of the Internal Revenue Code of 1986, as amended (or corresponding provisions of any subsequent federal tax law) by virtue of being charitable contributions as defined in section 170(c)(2) of the Internal Revenue Code of 1986, as amended (or corresponding provisions of any subsequent federal tax law).

ARTICLE III

The period of the Corporation's duration is perpetual.

ARTICLE IV

The purposes for which the Corporation is organized are:

(1) To operate exclusively for the benefit of and to carry out the purposes of Trinity Christian Academy (an organization qualified under sections 501(c)(3) and 509(a)(1) of the

Internal Revenue Code of 1986 (or corresponding provisions of any later federal tax law) and, as of the date of the incorporation of the Corporation, having an Internal Revenue Service Employer Identification Number of 75-132-4332; (Trinity Christian Academy shall be hereinafter referred to as the "Supported Organization")); provided, however, that in carrying out the foregoing purposes the Corporation shall always operate exclusively for religious, charitable, scientific, literary, or educational purposes within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986, as amended (or corresponding provisions of any later federal tax law); and

(2) To engage in any and all lawful activities incidental to the foregoing purposes, except as otherwise restricted herein.

The Corporation shall not carry on, other than as an insubstantial part of its activities, activities that are not in furtherance of its purposes.

ARTICLE V

In the event the Corporation is ever considered to be an organization other than a public charity (a public charity being defined as an organization which is within the terms of section 501(c) of the Internal Revenue Code of 1986, as amended (or corresponding provisions of any later federal tax laws) and is not a "private foundation" as defined under section 509(a) of the Internal Revenue Code of 1986, as amended (or corresponding provisions of any later federal tax laws)) the Corporation shall be subject to the following provisions:

(1) The Corporation shall distribute its income for each taxable year at such time and in such manner so that it will not become subject to the tax on undistributed income imposed by section 4942 of the Internal Revenue Code of 1986, as amended (or corresponding provisions of any later federal tax laws).

(2) The Corporation shall not engage in any act of self-dealing as defined in section 4941(d) of the Internal Revenue Code of 1986, as amended (or corresponding provisions of any later federal tax laws).

(3) The Corporation shall not retain any excess business holdings as defined in section 4943(c) of the Internal Revenue Code of 1986, as amended (or corresponding provisions of any later federal tax laws).

(4) The Corporation shall not make any investments in a manner that would subject it to tax under section 4944 of the Internal Revenue Code of 1986, as amended (or corresponding provisions of any later federal tax laws).

(5) The Corporation shall not make any taxable expenditures as defined in section 4945(d) of the Internal Revenue Code of 1986, as amended (or corresponding provisions of any later federal tax laws).

ARTICLE VI

The street address of the registered office of the Corporation is 17001 Addison Road, Addison Texas 75248, and the name of its registered agent as such address is Larry Kivioja.

ARTICLE VII

The number of directors constituting the current Board of Directors of the Corporation is twenty-five (25). The names and addresses of the persons who are currently serving as directors are:

The full and complete management and control of the Corporation shall be vested in the Board of Directors, the number of which shall be determined by the bylaws of the Corporation. This number shall be subject to change from time to time as the bylaws may be amended by the Board of Directors; provided, however, that the number of directors shall never be less than three (3).

Any action required by law to be taken at a meeting of directors, or any action which may be taken at a meeting of directors, may be taken without a meeting if a consent in writing setting forth the action so taken shall be signed by a sufficient number of directors as would be necessary to take that action at a meeting at which all of the directors were present and voted and if the requirements of Article 1396-9.10(C) of the Texas Non-Profit Corporation Act are satisfied.

The Corporation shall indemnify any person who was, is, or is threatened to be made a named defendant or respondent in a proceeding (as hereinafter defined) because the person (i) is or was a director or officer of the Corporation or (ii) while a director or officer of the Corporation, is or was serving at the request of the Corporation as a director, officer, partner, venturer, proprietor, director, employee, agent, or similar functionary of another foreign or domestic corporation, partnership, joint venture, sole proprietorship, trust, employee benefit plan, or other enterprise, to the fullest extent that a corporation may grant indemnification to a director under the Texas Non-Profit Corporation Act, as the same exists or may hereafter be amended. Such right shall be a contract right and shall include the right to be paid by the Corporation expenses incurred in defending any such proceeding in advance of its final disposition to the maximum extent permitted under the Texas Non-Profit Corporation Act, as the same exists or may hereafter be amended. If a claim for indemnification or advancement of expenses hereunder is not paid in full by the Corporation within ninety (90) days after a written claim has been received by the Corporation, the claimant may at any time thereafter bring suit against the Corporation to recover the unpaid amount of the claim, and if successful in whole or in part, the claimant shall be entitled to be paid also the expenses of prosecuting such claim. It shall be a defense to any such action that such indemnification or advancement of costs of defense are not permitted under the Texas Non-Profit Corporation Act, but the burden of proving such defense shall be on the Corporation. Neither the failure of the Corporation (including its Board of Directors or any committee thereof, special legal counsel, or members, if any) to have made its determination prior to the commencement of such action

that indemnification of, or advancement of costs of defense to, the claimant is permissible in the circumstances nor an actual determination by the Corporation (including its Board of Directors or any committee thereof, special legal counsel, or members, if any) that such indemnification or advancement is not permissible shall be a defense to the action or create a presumption that such indemnification or advancement is not permissible. In the event of the death of any person having a right of indemnification under the foregoing provisions, such right shall inure to the benefit of his heirs, executors, administrators, and personal representatives. The rights conferred above shall not be exclusive of any other right which any person may have or hereafter acquire under any statute, bylaw, resolution of members, if any, or directors, agreement, or otherwise. To the extent permitted by then applicable law, the grant of mandatory indemnification to any person pursuant to this article shall extend to proceedings involving the negligence of such persons. The Corporation may additionally indemnify any person covered by the grant of mandatory indemnification contained above to such further extent as is permitted by law and may indemnify any other person to the fullest extent permitted by law. The Corporation may purchase and maintain insurance on behalf of any person who is serving the Corporation (or another entity at the request of the Corporation) against any liability asserted against him and incurred by him in such a capacity or arising out of his status as such a person, whether or not the Corporation would have the power to indemnify him against that liability under this Article or by statute. Notwithstanding the foregoing, no person shall be indemnified pursuant to the provisions of this Article and no insurance may be maintained on behalf of any person if such indemnification or maintenance of insurance would subject the Corporation or such person to income or excise tax under the Code, including any tax asserted under Chapter 42 of the Code. As used herein, the term "proceeding" means any threatened, pending, or completed action, suit, or proceeding, whether civil, criminal, administrative, arbitral, or investigative, any appeal in such an action, suit, or proceeding, and any inquiry or investigation that could lead to such an action, suit, or proceeding.

ARTICLE VIII

The articles of incorporation and bylaws of the Corporation may be amended, repealed, or added to, or new articles of incorporation or bylaws may be adopted, by the Board of Directors; provided, however, that no alteration, amendment, repeal, or adoption of the articles of incorporation or bylaws shall be valid until approved by the Board of Trustees of the Supported Organization.

ARTICLE IX

The Corporation shall have no members.

ARTICLE X

No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to, its directors, officers or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered to or for the Corporation affecting one or more of its purposes.

ARTICLE XI

No substantial part of the activities of the Corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation, and the Corporation shall not participate in or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.

ARTICLE XII

Upon the dissolution of the Corporation, the Board of Directors shall, after paying or making provision for payment of all of the liabilities of the Corporation, dispose of all of the assets of the Corporation exclusively for the purposes of the Corporation as stated in Article IV, in such manner as the Board of Directors shall determine. If, at the time of dissolution of the Corporation, the Supported Organization is not then an organization which qualifies under section 509(a)(1) or 509(a)(2) of the Internal Revenue Code of 1986, as amended (or corresponding provisions of any later federal tax laws), the Board of Directors shall, after paying or making provision for payment of all of the liabilities of the Corporation, distribute such assets to such "eligible organization or organizations" (an organization shall be considered an "eligible organization or organizations" only if it or they are qualified under section 509(a)(1) or 509(a)(2) of the Internal Revenue Code of 1986, as amended (or corresponding provisions of any later federal tax laws)) as the Board of Directors shall determine exclusively in furtherance of purposes under section 501(c)(3) of the Internal Revenue Code of 1986, as amended (or corresponding provisions of any later federal tax laws); or any of such assets not so disposed of shall be disposed of by the Probate Court of the county in which the principal office of the Corporation is then located exclusively for such purposes, to such "eligible organization or organizations" as said court shall determine.

ARTICLE XIII

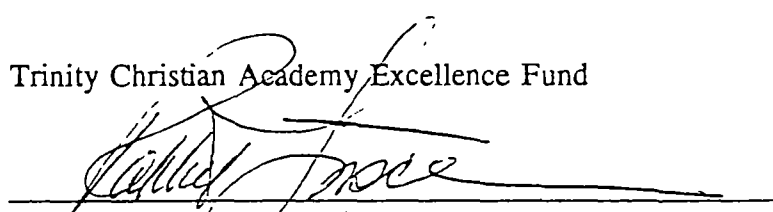
To the fullest extent permitted by applicable law, no director of the Corporation shall be liable to the Corporation for monetary damages for an act or omission in such director's capacity as a director of the Corporation, except that this paragraph shall not eliminate or limit the liability of a director of the Corporation to the extent the director is found liable for:

- (1) a breach of such director's duty of loyalty to the Corporation;
- (2) an act or omission not in good faith that constitutes a breach of duty of the director to the Corporation or an act or omission that involves intentional misconduct or a knowing violation of the law;
- (3) a transaction from which such director received an improper benefit, whether or not the benefit resulted from an action taken within the scope of such director's office; or
- (4) an act or omission for which the liability of such director is expressly provided for by statute.

Any repeal or amendment of this paragraph by the Corporation shall be prospective only, and shall not adversely affect any limitation on the personal liability of a director of the Corporation existing at the time of such repeal or amendment. In addition to the circumstances in which a director of the Corporation is not personally liable as set forth in the foregoing provisions, a director shall not be liable to the Corporation to such further extent as permitted by any other provision of these articles of incorporation, the bylaws, contract or agreement, vote of the directors, and by any law hereafter enacted, including without limitation, any subsequent amendments of the Texas Miscellaneous Corporation Laws Act or the Texas Non-Profit Corporation Act.
