THE BUCKLEY SCHOOL (THE "SCHOOL"), A CALIFORNIA NON-PROFIT CORPORATION, FOUNDED IN 1933, IS AN INDEPENDENT COEDUCATIONAL, COLLEGE PREPARATORY DAY SCHOOL LOCATED IN SHERMAN OAKS, CALIFORNIA. THE BUCKLEY SCHOOL IS PASSIONATE ABOUT ITS EDUCATIONAL PHILOSOPHY, THE 4-FOLD PLAN OF EDUCATION, WHICH BLENDS ELEMENTS OF TRADITION AND STRUCTURE WITH PROGRESSIVE, WHOLE-CHILD APPROACHES AND INCREDIBLE CREATIVITY. THE SCHOOL WAS FOUNDED ON THIS PHILOSOPHY NEARLY 80 YEARS AGO AND EVERY YEAR MORE AND MORE LEADING EDUCATIONAL RESEARCH SUPPORTS THIS APPROACH.

THE SCHOOL IS SITUATED ON A NINETEEN ACRE CAMPUS IN A RESIDENTIAL SECTION OF THE SANTA MONICA MOUNTAINS, WHICH PROVIDES A SETTING OF NATURAL BEAUTY WITH ACCESS TO THE CULTURAL AND EDUCATIONAL RESOURCES OF THE LOS ANGELES METROPOLITAN AREA. WITH AN ENROLLMENT OF 770 STUDENTS IN KINDERGARTEN THROUGH GRADE TWELVE, THE SCHOOL SEEKS TO ATTRACT STUDENTS WHO REFLECT THE ETHNIC DIVERSITY OF LOS ANGELES. BUCKLEY'S EDUCATIONAL PHILOSOPHY, THE 4-FOLD PLAN OF EDUCATION, COMBINES THE PRINCIPLES OF WHOLE-CHILD EDUCATION - A DEEPLY INTER-CONNECTED PROGRAM OF ACADEMICS, ARTS, PHYSICAL DEVELOPMENT AND MORAL EDUCATION - WITH A MORE TRADITIONAL FRAMEWORK. CURIOSITY, CRITICAL THINKING AND CREATIVITY ARE THE UNDERPINNING OF OUR ENTIRE CURRICULUM.
