NOTWITHSTANDING THE FOREGOING, UPON VOTE OF THE BOARD, THE ELECTION OF THE DIRECTORS MAY BE CONDUCTED BY MAIL BY BALLOT BEING SENT TO THE DIRECTORS THEN DULY IN OFFICE BY MAIL AT LEAST 14 DAYS BEFORE THE ELECTION DATE, IN WHICH EVENT THE ELECTION SHALL BE VALID ONLY IF AT LEAST 51% OF THE DIRECTORS SHALL CAST BALLOTS ON OR BEFORE THE ELECTION DATE.
