Nothing herein contained shall authorize this corporation to directly or indirectly establish, maintain or operate a day care center for children or to provide residential care for children or otherwise to undertake or carry on any of the activities specified in section 404(b) of the Not-for-Profit Corporation law or section 757 of the Executive law of the state of new york". Paragraph 7 was also amended to enlarge the territory in which the corporation operates to include "onondaga county and the counties contiguous to onondaga county in the state of new York".</p>
