Community Based Participatory Research Breast Cancer Survey  
Through a grant from the Life Sciences Institute, a breast cancer survey was conducted during the months of October 2010 through March 2011 in collaboration with the University of Texas San Antonio, the University of Houston School of Public Health and the University of Texas Health Science Center San Antonio. The purpose of the study was to develop a broad understanding of the knowledge, attitudes, behavior and practices regarding breast cancer among male and female Hispanic adults in Maverick and Val-Verde counties. The goal was to survey 700 households from each of the counties using trained promotoras. Southwest Border AHEC was responsible for implementation of the study in both counties. Approximately 24 community health workers (promotoras) were trained in the survey process and 2800 participants were reached in the colonias of both counties. The participants received a \$10 gift card for their participation in the survey (for a total of \$28,000 in expenses) and the promotoras were provided with a \$10 stipend for each household visited (approximately \$25,000 in expenses). A mileage stipend was also provided (\$3800). Other expenses included cost of training, supplies and travel. The results of the survey were presented to community leaders in both counties as well as association conferences.

College Enrichment Program  
In the late spring of 2011, Southwest Border AHEC collaborated with Southwest Texas Junior College in establishing a summer enrichment program for college students interested in entering the health professions. This was a 2 week 80 hour program designed to facilitate the entry of undergraduate students into medical and/or health care professional schools. The curriculum, which consisted of 4 enrichment courses to enhance their academic skills and competitive standing, included critical thinking, science enrichment, study skills and communication skills. A total of 20 community college students enrolled in the program with 95% graduating. Each student was provided with a \$100 stipend and the 4 professors each received a \$600 honorarium. Other expenses included materials, supplies and snacks.

Health Career Summer Camp  
In response to its mission in promoting health career activities as a means of recruiting health care professionals, Southwest Border AHEC conducted a health career summer camp for the third year in a row for high school students from the Eagle Pass Independent School District. A total of 17 students enrolled in the one week 30 hour program from June 13-17, 2011. Activities included hands on activities, insights from health care professionals (including physicians, dentists and nurse practitioners), CPR certification, skills practice and trips to health care facilities. Expenses related to travel to San Antonio to visit the marine animals of Sea World, medical supplies and other training costs. All students completed the program.

Explanation from Part II Line 10 \$60,863.37.

\$60,000 was received to implement a breast cancer survey among adult Hispanic men and women living in Maverick and ValVerde Counties. Approximately 2800 surveys were completed. The money was used to pay approximately 20-24 community health workers for each survey they completed and for gas expenses. A \$10.00 gift card was also provided to one adult living in each household for their time in completing the survey. The funds were also used for educational expenses in the training of the community health workers.

\$281.73 was a reimbursement for expenses incurred in implementing a breast and cervical cancer community education program during the March-September 2010 period. A total of 9 classes were conducted for 144 participants. Expenses related to snacks and refreshments that were provided to the participants.

\$496.64 were deposits that were refunded from an electric utility company upon closure of 2 apartments that were used to house health professions students. One deposit was in the amount of \$400 and the other deposit was \$96.64.

\$85.00 was a fee that was charged for CPR training of 7 employees.
