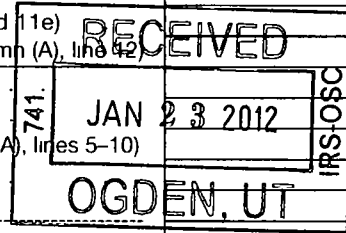

Activities involved treatment (for decontamination), securing permissions (from owners), marketing, photographing, annotating, storage, shipping, and developing website with auction functionality A kickoff auction preview event was held to secure media attention and launch the bidding Over 40 instruments were sold, many of which were treasured as memorabilia (previously owned / used by significant artists) but were damaged, not playable, and unsalable as functioning musical instruments.
