We have volunteers at the booth 12 hours a day for the 10 days of the fair answering questions about agriculture and discussing the display. The display showcased all of the vegetables grown in Indiana, showing people where their food comes from. Also at the booth was a question answer game with farm facts. Over 8,000 people from our county, the neighboring cities came through the building with our display. 50 volunteers contributed over 575 hours to making this a successful educational outreach project.
