Clinical Practice: The Family Institute (Institute) provides clinical services to clients from all walks of life. Staff therapists see clients at usual and customary charges. Revenue from the Staff Practice helps to cover the expenses of the sliding fee scale Family and Child Clinic (see below) where the average fee for service is under \$14.00.

4b (Code:) (Expenses \$ 2,252,127. including grants of \$ 295,739.) (Revenue \$ 2,168,890.)
Graduate and Postgraduate Education: The Institute manages two master's programs for Northwestern University in Marriage and Family Therapy and Counseling Psychology. About 50 students in each program learn applied clinical techniques to serve clients at the Institute and elsewhere in the metropolitan area. The Institute raises funds for scholarships for students in these programs. The Institute also provides externship training for both Clinical Psychology post-doctoral students and Psychiatric Residents from Northwestern University Medical School.

Family & Child Clinic/Outreach: The Institute provides services to under-served, under-resourced families in the Chicago Metropolitan area through our sliding fee-scale Family and Child Clinic as well as outreach to schools and agencies. Approximately 18,000 units of service were provided to low and no-fee clients. No client is turned away because of an inability to pay for services.
