Our YMCA programs, such as child care, summer camp, swimming lessons, swim team, youth sports and gymnastics, offer a wide range of experiences that enrich cognitive, social, physical, and emotional growth. Our Y has over 1,387 members under 18 (35%). Last year 200 youth utilized our child care programs. Scholarships make participation possible for all youth in our community. Healthy LivingThe Y is a leading voice on health and well-being. We bring families closer together, encourage good health, and foster connections through fitness, sports, fun and shared interests. This is particularly important as our nation struggles with an obesity crisis, families struggle with work/life balance, and individuals search for personal fulfillment. Our Y programs, such as fitness classes, sports, and wellness educational programs offer community members opportunities to enrich their lives with healthy habits. We also offer an indoor swimming pool, whirlpool, youth and adult fitness rooms, locker rooms, racquetball courts, and a gymnasium. Our programs are accessible, affordable, and open to all faiths, backgrounds, abilities, and income levels. Our Y has 3,930 members of all ages including 1,387 under 18.
