 Provided inpatient and outpatient renal dialysis primarily to residents of southeast Nebraska. At the end of FY 2011, the Dialysis Center of Lincoln had more than 230 patients. During the year, the Dialysis Center provided more than 34,000 outpatient hemodialysis treatments. More than 4,300 dialysis treatments were provided to hospital inpatients. In addition, the Dialysis Center participates in research programs related to kidney disease and treatment. Employees are encouraged, and many do, participate in local and national organizations which foster advancement in renal dialysis.
