THE ORGANIZATION ANNUALLY CONDUCTS AN AMATEUR RUNNING EVENT FORMALLY TITLED "THE CREDIT UNION CHERRY BLOSSOM TEN MILE RUN," WHICH CONSISTS OF THREE ELEMENTS: A TEN-MILE RUN, A FIVE KILOMETER RUN-WALK, AND A ONE KILOMETER CHILDREN'S RUN. THE EVENT PROVIDED THE OPPORTUNITY FOR APPROXIMATELY 16,000 TEN-MILE PARTICIPANTS, 1,700 FIVE-KILOMETER PARTICIPANTS WHO ARE MORE COMFORTABLE RUNNING A SHORTER DISTANCE, AND 150 CHILDREN, TO TAKE PART IN ACTIVITIES THAT PROMOTED THEIR HEALTH AND FITNESS, PROVIDED AN ENJOYABLE EXPERIENCE AND HELPED FIGHT CONCERNS OVER THE GROWING OBESITY CRISIS IN THE UNITED STATES. THE EVENT OFFERED EDUCATIONAL OPPORTUNITIES FOR PARTICIPANTS AT A SERIES OF CLINICS COVERING TRAINING, INJURY PREVENTION, AND NUTRITION, AT THE HEALTH AND FITNESS EXPOSITION.
