#### 4A. International Ministries

##### 1. Project Ethiopia:

a. PAWE HOSPITAL: Joshua's Way continues its partnership with Beza International Ministries in Ethiopia as it gives aid to the Pawe hospital and the Pawe Health Sciences College in the Benishangul-Gumuz region of Ethiopia.

b. PAWE HEALTH SCIENCES COLLEGE (formerly the PAWE NURSING SCHOOL): Joshua's Way provided 30 classroom tables and 100 chairs for the Pawe Health Sciences College to assist the College as it plans for expansion of its student body. Joshua's Way ordered the tables and chairs to be manufactured in Addis Ababa to further invest in Ethiopia. The tables and chairs were delivered at the end of March 2011.

c. WATER PURIFICATION SYSTEM: Engineering site visits for the installation of a water treatment system to provide potable water to the hospital and nursing school have been completed. This project has been delayed until governmental approval and permits are obtained from the regional health officials in the Benishangul-Gumuz region of Ethiopia. Joshua's Way is prepared to begin installation of this system within a matter of weeks of receiving the necessary approvals and is diligently seeking to obtain those approvals.

d. SOLAR COOKERS: Joshua's Way has explored ways to promote and facilitate the use of solar cooking in Ethiopia. Solar cookers help reduce deforestation, soil erosion, and the number of hours spent daily collecting firewood. Pulmonary problems from inhalation of smoke from cooking fires can be reduced with the use of a solar cooker. The initial distribution of 100 hundred parabolic solar cookers manufactured for Joshua's Way in Addis Ababa was completed in April 2011 in Pawe and in the Metekel zone just outside of Gilgel Beles in the Benishangul - Gumuz region of Ethiopia. Training in the use of the solar cookers was accompanied by the gift of a Bible in the Amharic language to each family receiving a solar cooker.

2. Cross Culture Network: Cross Culture Network, a ministry of Joshua's Way to international students, provides a variety of services to international students at upstate universities. Florin Palaghia oversees this ministry. Services provided to students include trips to acquaint them with historical sites in the United States, banquets to introduce them to American friends, a traditional Thanksgiving meal, discussion groups, Bible studies, "friendship partners" for these students while in the U. S., and practical assistance in finding furniture and other goods and services. The ministry to international students has grown to include students from Greenville Technical College, USC Upstate, and Wofford University in addition to ICAR students and students at Furman University. Nearly 70 international students participated in the Southern Hospitality Banquet in September 2010.

3. Venezuela Mission: Joshua's Way assists the Iglesia Cristiana Evangelica Church in La Puerta, Venezuela. The financial support of Joshua's Way helps this small, evangelical church reach out to its community through the use of AWANA, a program of Biblical instruction and discipleship for children. It also provides funds for medical assistance to some of that church's poorest members.

#### 4B. Teaching Ministry

Joshua's Way provided courses and seminars to give lay people a deeper understanding of the Scriptures and Christian faith and to encourage them to actively minister in the community. In March of 2011, Paul Rogers, Executive Director of Joshua's Way, and Johnny Price, President of The Caleb Group, led a seminar on *Grieving with Hope*. During this year, Rev. Alan Cellamare and A.K. Kuruvilla led the Joshua's Way Spring Conference on *The Bible in the 21<sup>st</sup> Century: Relevant or Ridiculous*. Joshua's Way also continued the Stellar Bible Study in Greenville every other Wednesday at the Upper Room Bistro.

#### 4C. Operation Christmas Child

Joshua's Way serves as a local collection center in cooperation with Samaritan's Purse for shoeboxes filled with gifts for children in foreign countries around the globe. Many upstate churches, schools, businesses and individuals participate in the preparation of shoebox gifts to carry an evangelistic brochure in the child's language sharing the gospel of Jesus Christ. Joshua's Way collected 10,955 shoeboxes during Operation Christmas Child 2010.
