The Health System Strengthening Area includes PHII (the Public Health Informatics Institute), TEPHINET (Training Programs in Epidemiology and Public Health Interventions Network), and the Global and Domestic AIDS Programs PHII’s mission is to improve the performance of the public health system by advancing public health practitioners’ ability to strategically manage and apply health information systems During the fiscal year PHII launched the inaugural cohort of PHII’s Informatics Academy, through the Universal Health Coverage Project, established shared business processes and requirements for health coverage information technology across eight countries, organized and facilitated a blue ribbon panel to access the bioinformatics needs of CDC, assisted CDC’s Division of Influenza define functional requirements for developing a comprehensive, integrated and interoperable laboratory information management system Created in 1997 as a professional network of field epidemiology training programs, TEPHINET is now active in 82 countries worldwide During the year, TEPHINET hosted the Sixth Annual Scientific Conference in Cape Town that included 550 delegates from 55 countries, expanded the FETP training program, opened a program office in Guatemala The Global And Domestic Aids Program produced over 5,000 toolkits for use in a national campaign to increase awareness of the dangers of drinking and transmission of HIV, Developed a training package and materials to build capacity among primary healthcare providers to ensure that all patients receive HIV testing and prevention counseling, and developed materials for use by community-based counselors in helping clients understand the risk of HIV and the importance of getting tested

The Neglected Tropical Disease Program Area (NTDs) includes the Lymphatic Filariasis Support Center (LFSC), The Mectizan Donation Program (MDP), Children Without Worms (CWW), and the International Trachoma Initiative (ITI) 450,000,000 treatments were approved for distribution through the NTD programs during the year For CWW, 75,480,000 treatments of Johnson & Johnson donated Mebendazole were allocated to 13 countries for distribution The ITI Program approved 53,800,000 treatments of Pfizer-donated Zithromax during the year 25,000 blood samples were collected by LFSC during a multi-country survey to determine how to assess the incidence of LF (Lymphatic filariasis) MDP approved 259,000,000 treatments of Merck-donated Mectizan and GlaxoSmithKline-donated Albendazole for the control of onchocerciasis (River Blindness) and LF respectively
