RESEARCH SHOWS THAT A YEAR AFTER LEAVING NICHOLAS HOUSE, 70% OF FAMILIES CONTINUE TO EARN A LIVING WAGE, MAINTAIN THEIR OWN HOUSING AND HAVE A HEALTHY FAMILY ENVIRONMENT.
