## 2011 Report to our Communities

Question for today and the future – how do we sustain Three Rivers AHEC in the current environment?

Sustainability is the capacity to endure. Simple yet complex. It embodies stewardship and well-established goals. For an organization, it is usually approached from a financial perspective which we believe is only part of it. For Three Rivers AHEC, we view sustainability from three perspectives – financially, demand for services, and succession planning. These perspectives were the focus of our strategic planning meeting with our Board and Team members during September 2011. We looked at each program area – recruit, train, and retain – and developed goals which will contribute to our sustainability from all three perspectives

The past two years have been tough in the financial sustainability arena with funding cuts and investment losses threatening us. As a Team we have always been good stewards of our money. However, it was

time to really streamline and it definitely paid off. For two years we operated with a Team of four – with everyone assisting in the Recruit program area. We accomplished our requirements, however, we did not serve as many of our communities as we have in the past as you will see later in this report.

One of the decisions made during the strategic planning process is to focus on organization development and investment. The staff position, Health Careers Coordinator, was reinstated as an investment in the organization. It is important that we keep a presence and be a resource pursued in our region. Preparing students for careers in health care is where the health career pipeline begins and is crucial to our mission. This investment will allow us to foster students and encourage them to pursue a health career.

Now, let's look at our accomplishments . . .

### RECRUIT- Preparing Students for Careers in Health Care

**The Chart the Course Academy** was developed to assist high school seniors in planning their route to a health career and staying on course! Since 2007, we have awarded \$15,300 in scholarships to 69 students who have successfully completed the Academy and Youth Volunteer Programs

#### *Chart the Course Academy-Three Rivers AHEC and Health Occupation Students of America (HOSA)*

Awarded 15 scholarships to assist HOSA senior students as they pursue their health career education – each scholarship was \$200. The students participated in the 5<sup>th</sup> Chart the Course Academy which partnered with the HOSA Chapters at three area high schools: Hardaway and Northside in Muscogee County and Harris County High School. The students successfully completed a yearlong portfolio of at least 20 hours of HOSA service and activities. One of the activities included a field trip to Philadelphia College of Osteopathic Medicine (PCOM)-Georgia Campus in Suwanee. The students learned about osteopathic medicine and were exposed to campus life of medical students.



**Distinguished Educator Award** Three Rivers AHEC proudly nominated Dr. Michael W. Early, Sr. as the Georgia Rural Health Association Distinguished Educator for 2011. He was selected for the award which was presented at the Georgia Rural Health Association's annual conference in Callaway Gardens September 2011. Dr. Early's practice, Early Family Medicine, is located in Ft. Valley, Georgia, where he has been in private practice since 1992. Dr. Early has instructed future physicians from Morehouse School of Medicine and students with the Mercer University School of Medicine Community Medicine Department, the Emory University Physician Assistant program, and the Troy University Nurse Practitioner program. Dr. Early is a noteworthy example of a physician who started his post-secondary education in Peach County and ultimately returned to serve the community by providing superb primary healthcare to friends and families with unmet needs.

- The mission of the **Good Shepherd Medical Clinic** is to meet the physical, social, emotional and spiritual needs of the medically underserved of the Greater Columbus and Chattahoochee Valley. They accomplish this with a caring, selfless team of volunteer physicians and support staff. With a growing patient base of over 1000, the clinic is often not able to schedule new patients to see a physician in a timely manner. These patients, who call this Clinic their medical home, have no medical insurance or the necessary funds to cover initial doctor visits and other medical needs.

In October 2011, Three Rivers AHEC teamed up with Good Shepherd and the Columbus Regional Family Medicine Residency program to see 165 patients in a two day "Catch-Up" Clinic. Without this event, the patients may have waited four to six months for an appointment with a health care provider. Students from the **Mercer University Physician Assistant program**, the **Anchor program**, and the **Columbus Technical College Medical Assisting program** joined Good Shepherd's volunteer physicians in treating these patients at absolutely no charge. Medications were prescribed from the discount and flat rate lists from various pharmacies in the community. **St. Francis Hospital** made arrangements for free or reduced cost imaging and lab services, and samples of medicines and supplies were donated and distributed.

This was a fantastic opportunity to contribute to the well-being and health of friends and family of our community. It was also a meaningful service learning experience for the students and an opportunity to boost the morale and productivity of the Good Shepherd Clinic.

- **Coordinated 437 clinical training rotations in 23 of our counties.**
  - 14 (61%) of these counties are designated as rural or Primary Care HPSA (Health Professional Shortage Areas). An additional 4 of the counties have census tracts that are designated as Primary HPSAs.
  - Students performing clinical rotations were from 26 health professions degree programs, i.e. Doctor of Medicine, Physician Assistant, Nurse Practitioner, Physical Therapy, Dentist, and Registered Nurse.
- **Enlisted 167 health care providers who served as volunteer community faculty (preceptors) providing 74,222 training hours.**
  - Of the 268 students trained, 22% were minority and 2% were from a disadvantaged background.
- **Provided housing or travel support for 218 student rotations valued at \$91,000.**
  - A majority of the clinical rotations in our rural or HPSA counties require students to leave their school/home base for a clinical rotation. The distance is too far for them to commute daily and thus can be a barrier preventing the student from being trained and thus exposed to the needs in these areas.



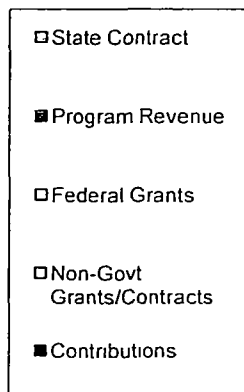
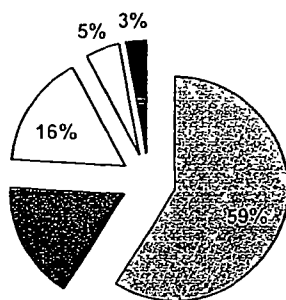
## ORGANIZATIONAL HIGHLIGHTS

  - We gladly welcome our new member to the Board of Directors, **Ajay Gehlot, M.D.**, CEO, of Southwest Georgia Health Care (SWGHC). SWGHC consists of 9 community health centers in southwest Georgia and provides primary health care services in Americus, Cochran, Cordele, Cochran, Cusseta, Eastman, Georgetown, Plains, Richland, and Rochelle. He has a Masters of Business Administration (MBA) from Georgia Southwestern State University and has over twenty years of clinical and administrative experience. He has a deep understanding and a broad perspective of the local and national health care environment. We look forward to working with Dr. Gehlot and the contributions he will make in moving Three Rivers forward.
  - Three Rivers AHEC was invited to participate in a training webinar hosted by the Health Resources and Services Administration (HRSA) Grantee Technical Assistance A-TrACC – AHEC-Training and Consultation Center. The topic was Continuing Education Evaluation and Performance Measures and featured as a best practice the collection and reporting of required state and federal data in our CE database. The one-hour training sessions were webcast live on March 22 and 28 as well as recorded and archived for on-demand viewing. Yvette Payton and Kathy English were the presenters.
  - Three Rivers AHEC was selected as the AHEC Center to spotlight for our Continuing Education and Distance Learning programs' outreach to rural healthcare providers by *The Rural Monitor*, online publication by Rural Assistance Center.
  - **Lighthouse Elite** was created to recognize our clinical training sites for their continued dedication to medical education! To qualify as an inaugural member, the clinical training site must have precepted at least 5 student rotations between June 1, 2009 and May 31, 2011 to receive initial offering of a staff member to attend one Three Rivers AHEC sponsored CE program at no charge – 19 community-based training sites were inducted as inaugural members. For every 5 student rotations precepted beginning June 1, 2009, the office qualifies for a staff member to attend one Three Rivers AHEC sponsored CE program at no charge. Most programs offer up to 7 contact hours in a variety of disciplines - \$75 to \$100 value!
