More than half of the money distributed by the Fund is designated to support the programs and facilities of the Winship Cancer Institute at Emory University. Winship is Georgia's only NCI-designated Cancer Center. Fund grants were used to recruit and retain faculty for dual appointments at Emory's medical school and the Winship Cancer Institute and to fund significant faculty research projects in cancer prevention, detection and treatment. About one-quarter of the Fund's total annual distributions are used to pay for Winship's facilities.

Fund grants supported strategic academic and research initiatives in the medical institutions that make up Emory's Woodruff Health Sciences Center. Significant support during this fiscal year was directed toward Emory's Center for Comprehensive Informatics and its Heart and Vascular Center. The Fund made a significant investment in the development of Emory's new Pediatric Center, a joint venture between Emory's Woodruff Health Sciences Center and Children's Healthcare of Atlanta. More than one-quarter of the Fund's total distributions are used to pay for non-Winship facilities within the Health Sciences Center, including Emory's biomedical research building, neuro-imaging center and School of Medicine building.
