NFN'S FOOD SUPPLY IS RECEIVED IN TWO WAYS: MONTHLY PURCHASES FROM LOCAL COMPANIES AND BY DONATIONS FROM CHURCHES, SCHOOLS, INDIVIDUAL COMMUNITY MEMBERS, EMPLOYEE FOOD DRIVES IN PRIVATE COMPANIES.

NFN LIFE SKILLS PROGRAM: NFN HAS LIFE SKILL CLASSES AND INDIVIDUAL COACHING SESSIONS; GED PROGRAM; JOB PLACEMENT; AND CLASSES THAT ADDRESS NUTRITION, ADDICTION, ANGER MANAGEMENT AND COMMUNICATION.
