IDRA is an independent, non-profit organization that is dedicated to strengthening public schools to work for all children. Founded on principles of ensuring equality of educational opportunity for every child, IDRA's vanguard leadership, development and research team works with others to create self-renewing schools that value and empower all children, families and communities.

The development fund provides resources for mission and priority program services not supported by external funding and for development of new programs. It facilitates the dissemination of knowledge about best teaching practices in classrooms with diverse students, the creation of materials that specifically address the needs of traditionally underserved students, and research on school finance and other indicators tied to the quality of education that all students receive. On average, this fund supports educational services that have a direct impact on 12,000 traditionally underserved students, 500 teachers, and 2,000 parents and community members each year. These services have a national focus with particular interest in Texas schools and the creation of equitable educational opportunities for all children.

4b (Code:) (Expenses \$ 689,905 including grants of \$) (Revenue \$)

The Equity Assistance Center is a federally funded project that serves school districts in a five state area: Texas, New Mexico, Oklahoma, Louisiana and Arkansas. On average, this project provides services to approximately 2,381 school administrators, 1,098 teachers, 195 parents, and 332 support educational personnel. The technical assistance and training assist schools to implement court-ordered desegregation plans and address matters of discrimination in public education based on race, gender and national origin. Center staff work closely with the Office for Civil Rights, the U. S. Department of Justice, state education agencies and other similar centers around the country to ensure that all students receive an equitable and high quality education.

4c (Code:) (Expenses \$ 739,109 including grants of \$) (Revenue \$)

The Texas IDRA Parent Information and Resource Center (PIRC) is a federally funded parent leadership support program for strengthening partnerships between parents and schools for student success. The PIRC informed over 87,000 participants face-to-face, through 64 conferences, 157 information sessions, 272 workshops, 30 trainer-of-trainer sessions, 21 video/Skype/webinar sessions and 253 planning sessions. About 5,000 of those parents received early childhood parent training services, in a variety of topics including Title 1 regulations, bilingual education, child growth and development, early literacy and parent leadership in education. They participated in HIPPI, Bowdoin Method, PAT, Even Start, Head Start and elementary schools early childhood settings. Additionally, a much larger audience was reached through mass media. From October 2006 to September 2011, information disseminated through newsletters reached over 200,000 parents and through articles, handouts, books and CDs to over 300,000. All those materials were directly related to the parent involvement goals and requirements of Title 1 under No Child Left Behind and the Texas Education Agency.

Part III Statement of Program Service Accomplishment 4d. Other program Service

TRANSITIONS – is a five-year federally funded project designed to enable school districts to tap into new groups of professionals who possess the background skills and basic foundation of prospective bilingual education and English as a second language (ESL) teachers. Through several program components, Transitions conducts high-quality pre-service coursework, teacher internships, mentoring and other new teacher support, and sustained in-service and professional development including strategies to influence retention. Under the No Child Left Behind Act (NCLB), teachers participating in an alternative teacher programs, such as Transitions, will be considered "qualified" and begin their certification as teachers of record.

MASS – The Math and Science (MASS) program is a federally funded five year project through which IDRA recruits, prepares, places and retains a critical mass of highly qualified mid-career professionals and recent graduates as middle and high school math and science teachers with an English as a Second language (ESL) supplemental endorsement for students in 10 high need Texas school districts. The goal of the project is to produce a rigorous accelerated and unique one and a half year program resulting in middle school and high school math or science certification with supplemental ESL endorsement, replicable with other disciplines

PATHWAYS – This program funded by the Charles Stewart Mott Foundation, uses an integrated approach focusing on building capacity in local communities to address the importance of expanding pathways for youth to complete school and graduate, integrating dual aspects of prevention and recovery. The goals of this program are to conduct structured roundtable discussions among community educational stakeholders to share and plan appropriate applications of the spirit of Brown and Mendez to the education of Latino and African American students.

CCVYP – The Coca-Cola Valued Youth Program, funded by the Coca-Cola Foundation, provides training, technical assistance, monitoring and evaluation to schools, implementing a cross-age tutoring program designed to address dropout rates. The project works with middle and high school students who tutor elementary school students.

CAMINOS – This project is a five year federally funded project through which IDRA has created a consortium of IDRA, four high-need Texas school districts and universities to certify 150 bilingual and bilingual special education teachers through an accelerated teacher preparation program.

The goal of the project is to produce a rigorous accelerated and unique one and one-half year program resulting in a critical mass of highly qualified bilingual/ESL teachers or bilingual/ESL teachers who also will become certified in special education.

SEMILLITAS – This project responds to the need for educational equity and culturally and linguistically relevant early childhood materials for Latino, Native and African American children. SEMILLITAS will result in the implementation of an innovative and integrated approach for early childhood equity and educational transformation for vulnerable Latino, Native and African American children in New Mexico, Oklahoma and Texas through community partnerships, culturally-relevant educational materials, training and technical assistance and an online community of learners. This program is funded by the

TG CAPACITY – Through this program funded by the Texas Guaranteed Student Loan Corporation, IDRA will build organizational capacity by enhancing its online OurSchool portal to include college success and preparation information. IDRA currently uses the portal to disseminate educational information in workshops (onsite and virtual), with parents, community members, educators and policymakers as well as making it available as a stand alone tool for the public. IDRA developed this tool to make comprehensible educational data available to families and communities so they may work with schools to improve outcomes for all our students.

PROGRESS – Through this grant from Marguerite Casey Foundation (Phase II), IDRA provides technical assistance to 13 organizations in the Rio Grande Valley of Texas that receive grants from the Marguerite Casey Foundation. The guidance and technical assistance provided enables these organizations to (a) develop a plan for an integrated progress monitoring system that is informed by an in-depth assessment of their current capacity and context, and (b) develops and uses an integrated system of data collection and analysis that inform and guides their work, reaching the capacity needed for sustaining impact.

IDRA has an established conflict of interest policy that is applicable to all of its officers, directors, and employees.
