Activities & Governance	1 Briefly describe the organization's mission or most significant activities AGENCY MISSION TO REDUCE DRUG AND ALCOHOL ABUSE AND ITS STIGMA BY PROVIDING GUIDANCE, EDUCATION, AND SERVICES TO CHILDREN, ADULTS AND FAMILIES SIGNIFICANT ACTIVITIES REVENUES REACHED A RECORD \$4.4 MILLION IN FY2010. BUT STILL OVER 69,000 CALLS WERE ANSWERED AND OVER 50,000 ADULTS AND YOUTH RECEIVED SERVICE. THE PR. FIRM OPEN CHANNELS GAVE THE COUNCIL \$49,000 IN IN-KIND SERVICES TO CREATE A TAG LINE, IMPROVE BROCHURES, WEB SITE AND OUR CAPACITY TO USE SOCIAL MEDIA. WE ASSUMED THE MORTGAGE OF THE COUNCIL BUILDING SITE IN DECEMBER 2010 REDUCING OUR ANNUAL FACILITY COSTS BY \$24,000. THE COUNCIL HOPES TO PAY OFF THE MORTGAGE WITHIN TWO YEARS.
