This years 31st annual 2-day Phoenix Pnde Festival continued to be a gathering created to educate the public about the existence and continuing civil rights battle of the metropolitan Phoenix LGBTQ community, as well as for the general public to celebrate the existence of its LGBTQ community The Festival had approximately 24,000 attendees and presented 275 exhibitors and over 150 entertainment performances on 5 stages Participation by government officials, government services, private corporations and celebrities continued to make the general public aware of their support for a prosperous LGBTQ community Festival program fees helped to fund over 48,000 in Phoenix Pride Partnership Grants for local non-profit organizations, as well as 35,000 additional program funding for the Phoenix Pride Community Grant Fund This year, the Grant Fund, administered by Arizona Community Foundation, awarded five 5 grants totaling 35,000 to GLSEN, Arizona Alzheimers Association, GPGGCC, Antri-Defamation League and Tumbleweed Youth Project in December 2011 at Prides Celebration of Giving
