Students become relied upon volunteers in their own communities, attend monthly planning meetings where they are mentored to take leadership roles at the international service site, and spend two weeks of their summer vacation serving in disadvantage communities in Cambodia, Kenya, Mexico, Peru and Thailand. In return for these commitments, Youthlinc students earn a sponsorship that pays a portion of their international service trip costs.

YOUNG HUMANITARIAN AWARD PROGRAM. The program recognizes Utah residents who are high school or undergraduate college students who excel in their efforts to give back to their communities. The overall winner of the award receives an monetary award to be used for tuition for either undergraduate or graduate studies at the college or university of the student's choice.

REAL LIFE IN SALT LAKE CITY. Allows Youthlinc students the opportunity to mentor and tutor refugee teens. The Real Life curriculum focuses on life skills (such as health, hygiene, career development, financial literacy) and cultural exchange through friendships formed through sport, the arts, and social activities. Youthlinc works cooperatively with the Hser Ner Moo Center to develop the project based curriculum.
