After School Extended Learning Day Program (ELD): Approximately 40 students, grades Kindergarten-8, participate in the ELD Program, an after school tutoring program with an emphasis on literacy skills and math. ELD teachers serve as student advocates, partnering with the students' school teachers to determine the areas of focus which would help the students perform better at school. Paid and volunteer teachers, as well as volunteer tutors, serve as tutors and mentors to the students. Assistance is provided with both subject matter tutoring as well as homework completion. Math students in grades 4-6 saw their average math scores increase 29 points through the course of the year, and 7th and 8th graders experienced an upward trend in their English and language arts grades.

Evening Tutoring Program: This is our longest running program, which grew 42% to serve 85 students, grades Kindergarten through High School, this past academic year. The evening program meets twice a week, and provides one-on-one tutoring and mentoring for the students to assist with both subject matter work as well as homework. Paid teachers provide instruction, and assist the tutor mentors. This year a new teacher was hired to work exclusively with high school students and their tutor mentors. 100% of the high school students participating in our Evening Program have graduated from high school, and all have gone on to either college or other post-secondary academic pursuits.
