The organization is run entirely by volunteers. All record keeping is computed, checked, reconciled, and reviewed by multiple parties

(in order to constitute better internal controls) At year end, the appropriate third-parties are contacted in order to clarify ending balances

for balance sheet accounts The CPA reviews the materials and makes year end adjustments (removing the CPA's independence)

Preparation of the Form 990 and its supporting schedules is completed using the accounting records, and is supplemented with background

information gathered from questions The organization's State Administrator is contacted to review the return If the return is correct, it is

signed and filed Copies of the final tax return are given to the Administrator and are kept for public inspection upon request
