Family Well-Being Program provides safety net resources for very low-income families, seniors and children by meeting their basic needs including food, clothing, enrichment, advocacy, and medical referrals.

Pantry Service is a free "clients' choice" program where guests get the option to "shop" weekly for an average of 45 pounds of nutritious groceries including fresh fruits, vegetables, meat, dairy, rice, beans and canned food serving 500 unduplicated families a month. The Center was the primary source of food for 35,476 individuals whose diets otherwise would be significantly deficient.

4b (Code) (Expenses \$ 573,018. including grants of \$) (Revenue \$)

Homeless Well-Being Program provides the homeless with six warm meals and sack lunches six days a week through served meal service and special meals on holidays. The Center provided 46,326 warm, nutritious breakfast and wholesome lunches. Six times a month health services are offered through two local agency partners. Additional services to ease the day-to-day suffering of the homeless include Health and Hygiene Services, Mail Service, Respite Care, and Resource Services.

Youth Empowered for Success Program offers enriching opportunities for children of the near homeless families served in community including After School Program, sports program, enrichment activities, and Youth Summer Camp Program.

After School Program offers educational support for 17 youth in grades 3-7, stresses the importance of family involvement in education, and promotes a college-bound educational path.

Summer Camp Program engaged 205 youth in a variety of activities that opened their eyes to new opportunities and a brighter future such as arts and crafts, cooking, science, dance, sports, all-girls leadership,
