However, the Fleet is subject to Federal income tax on its unrelated trade or business income of \$1,000 or more. Interest income of \$100 was taxable for 2011 and \$685 for 2010. The Fleet is eligible for the credit for small employer health insurance premiums. The credit for 2011 is \$1,064. The Fleet regularly
