Thereafter, any person elected or appointed to the Board of Directors shall automatically become a Governing Member upon his election or appointment and shall remain a Governing Member until the earlier of the time he/she resigns, dies, is removed, ceases to be qualified as a Director, or until the end of the meeting at which his/her replacement is elected. Governing Members shall be entitled not only to participate in all of the Corporation's activities, receive notices of meetings of the Governing Members and attend such meetings, but also to vote thereat.

The Human Resources Committee does not get involved in the remuneration or performance assessments of individual staff members other than the President and senior management. The Committee consults at least annually with the President and reviews recommendations from him with respect to compensation for members of the Corporation's senior management.
