During the Current year the Foundation gave a total of \$4,252,666 in grants to the Firemen's Association of the State of New York and \$250,000 to the FASNY Museum of Firefighting. A substantial portion of the grants to FASNY were used to support the operations of the Firemen's Home of the State of New York which provides a retirement and skilled nursing care facility to eligible former members of the NYS volunteer firefighting community.
