As Lead Agency of the Sarasota-Manatee Continuum of Care, the Partnership performed all required tasks and duties. The Partnership received a 90%+ customer satisfaction rating from member agencies.

4b (Code) (Expenses \$ 622,621 including grants of \$ 553,087) (Revenue \$)**HOMELESS PREVENTION AND RAPID RE-HOUSING PROGRAM**

The Partnership received, administered and provided data evaluation and reporting services for a federal HPRP (Homeless Prevention and Rapid Re-housing) grant, as subgrantee for Manatee County, and a Florida HPRP grant. The Partnership contracted with six (6) social services agencies to assist individuals and families that were homeless or at-risk of homelessness. Over 250 individuals and families were provided financial assistance through this grant, and HUD recognized the program with an Award of Excellence.

4c (Code) (Expenses \$ 159,564 including grants of \$ 137,188) (Revenue \$)**EMERGENCY SHELTER AND FINANCIAL ASSISTANCE:**

The Partnership received, administered and provided data evaluation and reporting services for a Florida Challenge Grant and CDBG grant (as sub-grantee of a City of Sarasota Grant). The Partnership contracted with three (3) social services agencies to provide financial assistance using grant funds to assist households that were at-risk of homelessness. The Challenge Grant assisted 482 individuals or families and the CDBG grant assisted sixty-three(63) households earning 80% AMI. HUD recognized the program with an Innovation Award.
