

Changes to the amended 2010 documents:

990-EZ: Address of organization – I updated the address to reflect the current address, though this is not where

the organization was located in 2010.

990-EZ: Part I – lines 1 and 9. The total raised was \$ 113,250 and not \$ 116,825.

990-EZ: Part I – line 16. \$5,119 was spent on bank and wire transfer fees. Schedule O was not included in the

original return. Nothing has changed in the amount of money listed.

990-EZ: Part I – line 18. This amount changed when line 9 changed. The correct amount is -\$1,911.

990-EZ: Part I – lines 19, 22a, 25a, 27a. This amount should have been taken directly from the previous year's

taxes. The correct amount, which is also listed on the 2009 990-EZ line 27b is \$ 3461.

990-EZ: Part I- line 21, 22b, 25b, and 27b. The amended number (\$1,550) reflects the amount that was in the

bank at the end of our reporting year and will be carried over to the 2011 taxes (which are also being amended

as a result of this error). I neglected to complete Part II on the original 2010 taxes so this has been amended on

the current version.

990-EZ: Part V – line 42A – I have updated the address to reflect where the books are currently kept.
