What is the organization's primary exempt purpose?

Camp Kirby, Inc (The Camp), provides a summer camping experience, located in Bridgeton Township, Bucks County, Pennsylvania, for hearing impaired boys and girls. The Camp is sponsored by the Lion's International Clubs of Bucks, Delaware and Philadelphia counties, District 14A. The Camp was organized as a non-profit corporation in the Commonwealth of Pennsylvania on July 14, 1986. District 14A purchased the 26.5 acre campsite on August 18, 1986 and held the first camp season in 1987. The Internal Revenue Service granted exempt organization status under section 301(C)(3) in an advanced ruling dated May 11, 1987 which applies retroactively to the inception of the Corporation. The camp's revenue is derived from the Lions-Clubs of District 14A and campers fees. Camp Kirby, supported by the Bucks, Montgomery and Philadelphia Counties of District 14A Lions Clubs has a long history of providing a beautiful, safe and fun environment for a summer camp experience for kids age 8 thru 15.
