What is the organization's primary exempt purpose?

The purpose of the organization is to provide knowledge and understanding of economics, matters of public concern, finance, education and training, and problems of minority groups thereby promoting the economy and quality of life in Abilene, Texas.

Part III, Line 31 - Other program services

Spotlight on Teachers Recognition - A program to recognize area educators to show appreciation and respect for their efforts in molding children and building future leaders. Expenses of \$5,115 including grants of \$0.

Dyess Air Force Base Support - Programs supporting the mission of the base by recognizing contributions of base personnel. Expenses of \$1,466 including grants of \$0.

Leadership Abilene - A program to educate future leaders of Abilene, Texas. Expenses of \$975 including grants of \$0.

Malcolm Meek Estate - Supported the Taylor County Livestock Show, providing area youth the opportunity to learn about agribusiness and to showcase livestock they raised. Expenses of \$1,000 including grants of \$0.

Miscellaneous - Various contributions supporting the programs of the Abilene Chamber of Commerce, a 501(c)(6) organization which has the exempt purpose of promoting the economy and quality of life in Abilene, Texas. Expenses of \$7,400 including grants of \$0.
