Area Agency on Aging - Provides assessment and care management services, in-home support services, adult day care, senior protection and advocacy, and senior center services. It also provides volunteer opportunities through the Retired Senior Volunteer Program and the Foster Grandparent Program. During the year the AAA provided assessments and care management for 3,880 clients, provided in-home services for 4,330 clients, adult daycare and domiciliary care for 29 clients, senior protection and advocacy services for 345 clients. The senior centers served 2,273 seniors and provided 21,541 units of service with it's Prmetime Wellness Program. It's volunteer programs had 598 participants

Child Development - Offers comprehensive quality preschool educational programs that prepare eligible children to be "school ready." Nutrition, preventative health and social services are also provided. During the year, the Head Start Program had a total enrollment of 883. The Pre-K Counts Program had enrollment of 68.

Education Training and Community Services - Promotes long term economic success for low-income individuals and families through education, training, case management and self sufficiency services. Education and Training services include adult education classes and academic support services for low-income youth with the potential for post secondary education. These services were provided to 2,030 clients. Community Services include housing and utility assistance provided to 1,441 clients, weatherization services (210 homes), and family support services (260 clients). Finally, the Food Services Program provided 315,505 meal and transportation served 937 clients.




