**LEGAL SERVICES: KIND PARTNERS WITH LAW FIRMS AND CORPORATIONS TO MATCH UNACCOMPANIED CHILDREN WITH PRO BONO ATTORNEYS TO ENSURE THAT AS MANY CHILDREN AS POSSIBLE WHO ARE REFERRED TO KIND HAVE AN ATTORNEY. THE COMPASSION AND DEDICATION OF THESE VOLUNTEER ATTORNEYS MAKE KINDS WORK POSSIBLE AND HAS CHANGED THE LIVES OF MORE THAN 1,500 AT-RISK CHILDREN.
