Neighborhood Stabilization Program. Purchased and rehabilitated foreclosed homes or apartment units in the Huber Heights and Trotwood areas. The homes will be rehabilitated to high standards to ensure long-term affordability and energy conservation and will be sold to buyers at 120% of the median income. This program is part of a four year multi-contract project with Montgomery County totaling over \$8.49 million. The Organization purchased 25 units for \$742,473, rehabilitation costs for the year were \$3,837,628, and carrying and disposal costs for the year were \$210,556. There was a subsidy of \$820,168 for 11 homes sold this year.

Loans and Grants for Residential Rehabilitation. Financed or facilitated 82 loans and/or grants which were used to rehabilitate residential properties. The Organization also serviced 479 loans.

Housing Trust & Community Development Financial Institution Programs. Provided funding for 93 low and moderate income housing units in Montgomery County. Projects included acquisition, rehabilitation, and construction of housing units. The Organization also serviced 133 loans.
