This program encourages and supports youth from lower socio-economic neighborhoods to prepare for, succeed in and to complete high school with a plan for their future. Approximately 90 youth, aged 14 through 18 are enrolled in this program. The grant supports staffing for the program including the positions of Program Director and three site directors, each of whom also serve as mentors.
