Russian Ministries' publishing efforts are designed to stimulate voices from within the former Soviet Union to cultivate a Next Generation of published Christian writers who can speak directly into the cultures and peoples of the former Soviet Union. Each year, Russian Ministries oversees the publication and distribution of 10-12 titles that are used for Next Generation leadership development through School Without Walls seminars, leadership training conferences, pastoral training seminars and conferences, forums and roundtable discussions. Each title represents the contemporary thought of young, national Christians as they present solutions to the challenges facing the evangelical church and society in the former Soviet Union. In addition, because we recognize that Scripture has the power to change lives, Russian Ministries prints and distributes thousands of copies of specialized versions of Scripture throughout the countries of the former Soviet Union, including New Testaments for youth, New Testaments for Muslims, children's picture Bibles and New Testaments, and others. We estimate that approximately 100,000 people are reached annually through the publication/distribution of these Scripture versions.

The distribution of humanitarian aid (GIK) is an important component of our efforts to minister holistically to the Next Generation in the former Soviet Union (FSU). Each year thousands of people are reached through the distribution of:

*** Gifts of Hope gift packs (containing toys, candy, clothing items, and a children's Bible or other Christian literature) placed by School Without Walls students at Christmas, Easter, and other strategic times of the year.**

*** Clothing, shoes, furniture, medical equipment, bedding, wheelchairs, food and other items delivered either directly by School Without Walls students or through local churches and other Christian organizations.**

Relief work enhances our evangelism efforts and often leads to entire families attending church and accepting Christ.

Russian Ministries has greatly invested in church-planting over the years, yielding hundreds of new churches planted and thousands of trained church-planters, bringing huge impact to the FSU. New realities, however, require revised strategies in church-planting, especially the involvement of School Without Walls students and graduates through offering training seminars, roundtable discussions, and practical resources in Russia (including the predominantly Muslim Northern Caucasus), Belarus, Ukraine, Moldova, and countries of Central Asia. Through these efforts, we estimate that 5-10 new church plants will be established annually. Russian Ministries also continues to engage an increasing number of existing national churches in ministry through our School Without Walls and other leadership training programs, leading to increased church growth and more effective outreach in the community.

Project Hope- Through this Christmas evangelistic outreach project, Russian Ministries School Without Walls students, graduates and other young Christian leaders work through their churches in distributing gift packs with Bibles and Christian literature to needy children in the FSU

Part VI line 10 - PDRM monitors and enforces compliance with our conflict of interest policy by administering an annual questionnaire and by consistently reviewing transactions for related party activities.

Part VI line 15b - On an annual basis the Board of Russian Ministries designated one of its members or an outside independent party to compile information upon which it will make a determination of annual compensation for the president. This information shall

Include job performance and comparability with similar-sized organizations in the same metro area as the headquarters.

Part VI line 19 - Russian Ministries makes its governing documents, conflict of interest policy and financial statements available to the public in its headquarters office. In addition, single copies are available without charge by writing to the organization.

Part VI line 11 - PDRM sends a copy of the completed 990 to all Board members for review before filing. Board members are asked to review the 990 and respond.
