Family Preservation - The organization served 1,716 families across seven counties: Genesee, Lenawee, Macomb, Oakland, Shiawassee, Washtenaw and Wayne. Follow-up inquiries at six, twelve and eighteen months indicate that children in 96% of the families served were able to remain safely in their parents' care.

Kinship, foster and treatment foster care; independent living - We cared for an average of 389 youth each day over the last year in our foster care program. We successfully recruited 103 new individuals and families to serve as foster and potential adoptive families. We monitored and supported parents' efforts to reconnect with their children and returned 175 youth to their parents' care.

Adoption - We served 295 children and facilitated 110 completed adoptions. We also began consultative services under contract with Michigan DHS to expedite adoptions in process at other agencies.
