Skilled Nursing Care

Warroad Care Center has the ability to provide skilled care to 49 residents.

For fiscal year ending 09/30/2011 we had census days of 16,389 which averages 44.9 residents. Medicaid consisted of 12,359 which averages 33.86 days. Private has 2,997 census days which averages 8.15 days. Medicare A has 1,033 which averages 2.83 days.

Assisted Living

Warroad Care Center has 22 apartments available for general assisted living care.

For fiscal year ending 09/30/2011 we averaged 21.36 apartments filled. For services, these residents are able to utilize elderly waiver, and other county programs if they qualify. Of the 22 apartments, 14 apartments are HUD.

We have 4 residents who are able to participate in our mission benevolence fund. In order to qualify, residents must meet HUD requirements, and need to be eligible for a minimum of 2 services. This is also available in Supportive Care

Independent Living and Supportive Care

Warroad Care Center has 22 apartments available for Independent Living and 10 apartments available for Supportive Care

For fiscal year ending 09/30/2011 we averaged 21.78 apartments filled. We have no financial subsidy programs in place for Independent Living

For fiscal year ending 09/30/2011 we averaged 9.38 Supportive Care Apartments filled. REsidents are able to receive elderly waiver and other county programs if they qualify.

We have 4 residents who are able to participate in our mission benevolence fund. In order to qualify, residents must meet HUD requirements, and need to be eligible for a minimum of 2 services. This is also available in Assisted Living


