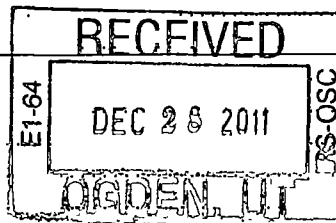

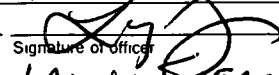

CASS COUNTY COMMUNITIES REQUESTED ASSISTANCE IN SECURING AND ADMINISTERING GRANTS.
DURING 2011, GRANT FUNDS WERE SECURED WITH THE ASSISTANCE OF THE EDC.
HACKENSACK AND PINE RIVER RECEIVED GRANTS FROM THE SMALL CITIES DEVELOPMENT
PROGRAM TO REHABILITATE COMMERCIAL BUILDINGS AND OWNER OCCUPIED HOMES.

THE CASS COUNTY ECONOMIC DEVELOPMENT CORPORATION ADMINISTERED THE JOBZ PROGRAM, AS
