OCS Exemplary: The Exemplary Practice Project (EPP) focused on job creation and green jobs throughout the Missouri Community Action network. The EPP was a collaborative effort between four Missouri CAA's, the state CSBG Lead Agency, and the Missouri Association for Community Action. The outcome of the project was to conduct feasibility studies (urban, rural, renewable energy) and develop business plan templates to create "green" renewable job opportunities, that are responsive to locally identified community needs and enhance current community services programs.
