 Established in 2000 with a generous grant from the Siragusa Foundation, the Siragusa Scholarship Fund for special needs adoptive families enables The Cradle Foundation to provide financial assistance to dozens of families each year whose children face unique challenges. Cradle adoptive families can apply for awards up to \$1,500 annually for needs ranging from therapy to medication to special equipment such as a wheelchair or hearing aid. In fiscal 2011, the Siragusa Scholarship Committee awarded \$28,600 to 42 Cradle Families on behalf of 49 children.
